1. Apologies

There were no apologies.

- 2. Members to declare personal & prejudicial interests (incl details thereon) re any items on this agenda and any dispensations thereon previously granted or requested now There were no declarations.
- 3. Public questions (15 minutes in total -2 minutes each to speak on agenda item or raise a new subject). This is your only chance to speak unless invited to do so elsewhere by the Chairman.

The church bell tower captain asked the Parish Council to consider holding the Remembrance Sunday service on 11/11 at the church instead of at the war memorial as it is 100 years this year since the end of WW1. There was a memorial in the Lady Chapel within the church and muffled bells would be rung. It would be put on the next agenda.

Water flowing down the Helston side of Rosevear Hill was flooding a garden because a manhole grid was not big enough to take it away. Cornwall Cllr Julian Rand would look into the matter.

Two new electricity poles had been dropped on the grass at Mawgan Cross (adjacent to Thatches) and one had remained there for months. A member advised that Western Power had left it there for replacing all the HV lines but the weather had been too wet. Council would contact WPD to get it removed.

4. To receive Cornwall Cllr Julian Rand's report

A £3m spend on a new stadium for Cornwall was approved after 50 Cornwall Cllrs spoke on the matter. A further £3m was required from the government or it would still not go ahead. There was also £8m due from private investors. At a recent Children & Families Overview & Scrutiny Committee meeting it emerged that amongst 10-16 year old disabled children 25% had a stress related issue. A survey was being carried out on home schooled children but it was not known how many there were. The following day would see a meeting of the chairs of the LAG groups. A new fund that encompassed both ERDF and ESF European funding was being launched, which would run until 2021. £6m was in the Community Led Local Development (CLLD) pot but the area or adjoining area had to be in multiple deprivation. Andy Hoskin of Cormac, who had met Cornwall Cllr Julian Rand to look at the problem with the drains around the church, had advised the new owners of Glebe Hall what was planned for the drains.

- To confirm the minutes of the previous meetingIt was RESOLVED that the minutes of the previous meeting be signed by the Chairman as a true and accurate record.

 - a) PA18/01809 Construction of a learning centre, siting of nine holiday lodges, creation of informal parking, construction of a jetty and hoist, landscaping, paths and ancillary works, Trevassack Quarry, Goonhilly Downs, Helford River Children's Sailing Trust It was RESOLVED to support the application as such alterations to the original application were necessary for the type of clientele that would be using the facility.
 - b) PA17/09613 Proposed eco holiday chalets, Countybridge Fishery, Goonhilly Downs, Mr J Owen It was RESOLVED to recommend refusal of this application due to there being no business plan and the fact that the site never had planning permission for a fishery. Vote 8out of 9 in favour of refusal.

This had been dealt with at a meeting immediately before this Parish Council meeting.

10. To discuss repair of Glebe play area roundabout; it has been removed to workshop but now in much worse state than when originally quoted a year ago and will cost £3995.00 to repair

In view of this development the Clerk had requested Kompan to put a hold on commencing installation of the swings and to send a quote for a new roundabout. A quote was received for a more modern type of roundabout that children could stand/hold onto in the sum of £5293.31. She felt that something could be reduced from this figure because there was duplication of site fees, etc with the first swings job. It was RESOLVED to finally abandon the original roundabout, it might be repaired and then the bearing fail, and to purchase a new Kompan roundabout at a cost of £5293.31.

11. To receive update with regard to defibrillator provision in Parish

The winter operating evaluation for the solar defibrillator cabinet would not conclude until the end of April so nothing would be known until sometime in May but assuming everything was successful, the Clerk would re-submit the order for the defibrillator once the results were known. A decision had to be made as to whether a pole was required to mount it in the grass at the end of Glebe Close bus shelter or whether it should just be mounted on a wall of the bus shelter. It was agreed a pole was not required as Coastline would complain about not being able to mow the grass and it would be on its land.

12. To discuss who will paint Rose-in-the-Bush defibrillator kiosk with donated red paint
The person who maintained the grounds around the village was already lined up to paint a
kiosk in another parish so he would be asked to do it.
