## 1. Apologies

Apologies for absence were received from Cllrs C Chapman, A Hoskin and A Harris.

The member of the public present had no questions but hoped Cornwall Cllr Julian Rand had some answers.

## 4. To receive Cornwall Cllr Julian Rand's report

Cornwall Cllr Julian Rand had not received any response/follow up from his meeting on 13<sup>th</sup> March with Portfolio Holder for Transport Cornwall Cllr Geoff Brown so would have to chase it. He had joined the meeting outside Garras School to discuss the parking problems there. The Police attitude was that it created traffic calming but this was not what people wanted. He mentioned he had spoken to the owner of the field next to the school and Recreation Hall about having access to some extra land for parking. The owner had intimated that he would be quite happy to come to some arrangement to include more play area. Cornwall Cllr Julian Rand felt the best option would be to extend the existing yellow lines. The school and PCSO Julia Berry had no authority over parking; it was now down to a warden scheme operated by Cornwall Council. He was waiting to hear the result of a head teacher/land owner meeting. The Chairman suggested that some children travelling from Helston attending the school could travel by minibus (the school minibus). Other than that Cornwall Cllr Julian Rand had attended the usual monthly meetings plus Head Start Kernow event at the Eden Project (for mentally challenged children) and a Cornwall Council event at Heartlands to discuss 2021 when the number of Cllrs would drop to 87. They were described to be more 'strategic', (which he took to mean not as involved or close to the community as he feels they should be). The day before he had attended the full council meeting, where they discussed the capital programme. Cornwall Council would purchase 250 properties for emergency /homeless accommodation instead of private renting of B&B's, hotel rooms, etc. A new company structure would be set up to control it. Another issue up for discussion was the lack of NHS dentists in the County.
