1. Apologies

There were no apologies.

2. Members to declare personal & prejudicial interests (incl details) re any items on this agenda

There were no declarations.

4. To receive Cornwall Cllr Julian Rand's report

Apart from the usual monthly meetings, Cwll Cllr Julian Rand had attended the meeting at Cormac, Scorrier with Rosevear residents on 24th January. This was with Andy James (Head of Highways & Environment) and Adrian Roberts (a member of the road safety design team). 15 residents attended when it was agreed to try and make the start of the 40mph more obvious by installing 'gateways' at the start of the speed limit, like those at Perranarworthal – little white fences in the verge underneath the speed limit sign. Speeds would also be measured (not traps) to get an indication of what was happening on the hill.

Double yellow lines would also be installed between the Mawgan roundabout and the school for approx. 20m and opposite the school from the existing end of lines to the roundabout in order to prevent parking opposite the school and move it away from the roundabout as well. The Clerk would check whether this was going ahead already or whether Council had to complete an EOI form for the next TRO round.

He had also attended the February CNP meeting where they had presentations on affordable community led housing and community enforcement – (hidden eyes ‘we are watching you’ signs would be put up in strategic dumping/littering places.) There was a meeting at Heartlands discussing the future 87 Cllrs instead of the present 123 Cllrs and members had a briefing on the ‘grid’ with a view to smoothing out renewable energy production as the grid could not accept it all when in peak production. A new company was being formed to buy up property as an investment for Cornwall Council and climate change would now be considered regarding planning decisions. Members noted there were potholes down Skyburriowe Lane, especially the Garras end and around the former mill.

It was RESOLVED to spend the necessary money for both as the PC had taken over maintenance of the churchyard when it closed in 1999. The Clerk would find out whether Council's insurance covered trees on the closed churchyard boundary.
