1. Apologies

Apologies for absence were received from Cllr Vivian Benney, Cornwall Cllr Walter Sanger and the Police.

2. Members to declare personal & prejudicial interests (incl details thereon) re any items on this agenda and any dispensations thereon previously granted or requested now

There were no declarations.

3. To receive PCSO Julia Berry's monthly report

There was no Police report.

4. Public questions

A member of the public reported that a car had gone into the wall on the school corner on a Sunday morning so calming measures were still very important both at Rosevear and at the school. It was reported that an average speed sign cost £60k to install plus running costs therefore it was highly unlikely that Mawgan would get a pair of them. It was noted.

5. To confirm the minutes of the previous meeting

It was RESOLVED that the Chairman sign the minutes as a true and correct record of the previous meeting.

6. Matters arising from the minutes – not covered elsewhere in this agenda

A member mentioned the AONB sign proposed for Rosevear Hill and rather than it going in the lay-by down by the bridge suggested that it go up at the Gweek junction. However, the member was advised that the AONB boundary was not up that far.

7. To consider planning applications received from Cornwall Council

- a) PA15/10813 Dining room, porch and link extensions, internal alterations, Little Nanspean, Gunwalloe, Mr Steve Wilson

It was RESOLVED to recommend approval of the application.

- b) PA15/11091 Additional modular classroom, Garras County Primary School, Garras
This was assumed to be the previous application but an 'amended' site for the classroom, not an 'additional' classroom, which would give 2 additional classrooms

if the previous application was implemented as well. On this basis it was RESOLVED to state that *if this is an amended site for PA15/05819 then Mawgan Parish Council supports the application. However, if it is not, then please clarify the situation vis-a-vis the two applications.*

Whatever happens at the school; the traffic/parking situation needs looking at particularly with regard to a 20mph limit outside the school. Also the roundabout on the B3293 gets blocked now with parked cars at school arrival and departure times and is likely to get intolerable with the predicted increase in student numbers next September.

11. To receive applications and co-opt to fill casual vacancy on Council

Two applications had been received so a paper ballot was held to select one. The result found in favour of Mr M Laity – by one vote. It was RESOLVED that Mr M Laity be co-opted onto Mawgan Parish Council and the other applicant would be advised that Council was aware of their interest and would keep their details on file for any future vacancies.

12. To consider donation of £100 to Gweek Band in lieu of Feast Sunday concert

This had been paid by the Recreation Hall Committee out of the Feast Saturday money.

13. To receive report on Christmas lights switch on

The Chairman reported that this had gone well. However, with regard to presenting certain people with flowers for work put in; he felt flowers should go to the lady who donated the tree and star. Flowers given out on the night left some people unrewarded. Another

member felt it should not happen another year. It was RESOLVED that a bouquet of Scilly flowers be sent by post to the donor thanking them. Cllr Mrs Pearl Merton also suggested photographing the illuminated tree, framing it and sending it to the donor. This was agreed. The Chairman and his wife were thanked for providing food and wine on the night. It was agreed to invite the lights committee to the next meeting to discuss them taking on the tree as well in future.

14. Items for inclusion on next month's agenda

Christmas lights committee, whether to celebrate Queen's 90th birthday during Feast week.

15. To receive the financial statement

£23,109.30 was in the bank. It was noted.

16. To consider budget and set precept for 2016/17

After much discussion about the amount suggested by the Clerk, it was RESOLVED to limit the increase in the precept to approx 2% and request £24,500 from Cornwall Council.
