1. Apologies

Apologies for absence were received from Cllrs Vivian Benney and Anthony Hoskin. Vice-chairman Cllr Michael Laity took the Chair.

There were no declarations.

4. Minutes

It was RESOLVED that the minutes of the last meeting be signed as a true and accurate record.

5. To receive Cornwall Cllr Guy Foreman's report

Things were relatively quite at County Hall. Cornwall Council was hoping to push recycling levels up by asking people to recycle more plastic bottles such as shower and shampoo bottles. The first wave of the new refuse & recycling collection service was starting in St Austell. It would start on the Lizard Peninsula in April 2024, with bins/bags being distributed before then. On the matter of septic tank emptying, he met with SWW a week earlier. It has now significantly upped its game. It will now accept sewage from tankers at four places, not just Hayle. It has also changed its booking system to allow for shorter notice bookings. The completion of Hayle facility was imminent. Highways; a ghost island was being installed in Meneage Road, Helston to allow for a new pedestrian crossing. Traffic queues were likely.

6. To receive update on CLUP application submission for hall funds

On 12th October 2023 Cllr Catriona Pennell and the Clerk met Ella Rodwell Cornwall Council CLUP facilitator and Naomi Gorvin of CRCC Rural & Coastal Community Lead, together via online, with Heather Emberson-Marl fishing animateur also of CRCC Rural & Coastal who writes bids for fishermen's grants and would be able to assist if we wished to engage paid

help. Initially Mawgan had a single EOI submitted but was then advised by a temporary facilitator to split it between capital and revenue – two separate applications. This, as it turned out, was probably not the best advice. The Rural Fund part (capital) appeared to get lost by Cornwall Council and now the deadline had passed, with Council hearing nothing about the EOI for it. Council now has to return to the CLUP fund (revenue part previously applying for) for the whole amount. On 12th October Cllr Pennell re-submitted the original single EOI to CLUP but to now cover both capital and revenue – i.e. the whole amount required. Council had already obtained planning permission but building quotes and public consultation was also required before it could go any further. The Clerk was seeking quotes from local builders for funding application purposes only.

7. Matters Arising from the minutes not covered elsewhere on this agenda

SWW Hayle tank was now due to complete on 24th October 2023.

Bank signatures had finally been changed.
